



HOW TO APPLY ONLINE – SOLARIS SHALIMAR E-LOTTERY 2024

1. Apply Online through our Sales Partner [SureHomz](#)
2. Register / Log in on [SureHomz](#)
3. Make Online payment on SureHomz.com to buy **SOLARIS SHALIMAR E-LOTTERY 2024** Online Application Kit. You can pay through Credit Card/ Debit Card/ Net banking or other payment modes available on the website.
4. Online Application Kit is priced at ₹ 200/- (non-refundable)
5. Online Application Kit will include:
 1. USER ID for Online Application Form
 2. General Terms and Conditions
 3. E-Brochures
6. Fill up the Online Application Form correctly and completely. Please do not leave any options blank. A few important things to keep in mind are:

 2. You need to have a valid IT PAN card to apply for a flat at Solaris Shalimar.
7. You should compulsorily submit duly filled-in Application Form and GTC acceptance online in the prescribed format.
8. The Applicant can choose multiple Flat Groups along with preferences as provided in the Application Form in terms of the GTC but the Application Amount to be paid by the Applicant shall be the maximum amount among the preferred Flat Groups selected by the Applicant, irrespective of the preferences. e.g. if an Applicant selects D Type and C Type group then the Application Amount for D Type Group being higher shall be the amount required to be paid by the Applicant.
9. The Applicant shall compulsorily provide his/her preference of Flat Group if more than one group has been selected. If the preference for Flat Group is not provided or is illegible or is incomplete then the default preference in the following order i.e. 1st preference "Flat Group E1", 2nd preference "Flat Group E", 3rd preference "Flat Group D3", 4th preference "Flat Group D2", 5th Preference "Flat Group D", 6th Preference "Flat Group C1", 7th Preference "Flat Group C", 8th Preference "Flat Group B3", 9th Preference "Flat Group B2", 10th Preference "Flat Group B1", 11th Preference "Flat Group B" and 12th Preference "Flat Group A" and shall become automatically applicable.
10. The Eligible Applicant must mandatorily provide the Floor Preference of Standard and/or Prime Units. Standard Unit being flats of all types situated on the Ground Floor to the 6th (Sixth) Floor of any tower in the Complex and the Prime Flat being Flats of all Types situated on the 7th (Seventh) Floor to till the top floor of any tower in the Project.
11. If the Flat Floor Preference of Standard Flat and Prime Flat is not provided or is illegible or is incomplete then the default preference of Standard Flat as being the preferred option of the Eligible Applicant shall apply. In case the choice applied for by the Eligible Applicant for Unit

Floor preference is not allotted in the preferred floor type, the next floor type shall automatically apply.

12. Pay the Application Money electronically through Credit Card/ Debit Card/ Net banking or other payment modes available on the website. Please ensure that your Application Form is updated with your payment information.
13. Based on the mode of transaction, applicable convenience/transaction charges, if any, might be levied upon the Applicant.
14. Upon successful submission, the Applicant will get an 'e-acknowledgement' generated for records. It will be the responsibility of the Applicant to note down and store the Transaction ID of payment of application money for future reference.
15. In the event of any problem involving online payment of the application money, the decision of the intermediary, whose portal is being used would be final regarding authenticity of such transaction.
16. In situation where online payment is accepted but subsequent uploading of the filled-in Application Form or generation of payment acknowledgment could not happen, the applicant should contact the Promoter referring to the Transaction ID and the Application Number. On such an event the Promoter will take necessary steps to complete the application process, subject to confirmation of such transaction from the intermediary.
17. Convenience/Transaction charges (if any) payable on account of online payment of Application Money shall at all times be non-refundable.
18. There will be no other acknowledgement for receipt of the Application Form or the Application Money paid.
19. Name of any Joint Applicant may be added along with the name of the Primary Applicant at the time of filling of Application Form.
20. Please submit your completed Application Form and pay your application money on or before **28th January 2024** to avail Priority Allotment Scheme or on or before **12th February 2024 (Last Date for Submission of Application)** to participate in the Solaris Shalimar E-Lottery 2024.
